It has good colour retention. If enhanced slip resistance is required Jotafloor Non Slip can be used in the system. To be used as primer and finish coat in atmospheric environments for properly prepared concrete substrates.

Application methods

The product can be applied by

Spray: Use airless spray (thin 5 %).

Brush: Recommended for stripe coating and small areas. Care must be taken to achieve the

specified dry film thickness.

Roller: May be used. Care must be taken to achieve the specified dry film thickness.

Conditions during application:

The temperature of the substrate should be minimum 10 °C and at least 3 °C above the dew point of the air, measured in the vicinity of the substrate. Good ventilation is usually required in confined areas to ensure proper drying. The moisture content in the substrate should not exceed 4 % (by weight). The coating should not be exposed to oil, chemicals or mechanical stress until fully cured.
