PRODUCT **D**ESCRIPTION

A water based degreasing agent based on a blend of plant derived surfactants free from caustic alkalis, silicates, harmful solvents, phosphates or aggressive biocides

RECOMMENDED **U**SE

Suitable for removal of dirt, oil and grease from all ferrous and non-ferrous metallic substrates (including galvanised steel).

Recommended Application Methods

For manual application methods dilute 1 part Degreaser W500 in 5 to 20 parts warm water, apply to surface by brush, sponge or clean cloth. Wipe over surface and rinse with clean water, leaveto dry as necessary.

For pressure washers, use at 1 part with 10 to 50 parts water, depending upon amount of contaminant to be removed. Use medium or high pressure. Hot or cold water may be used, heavy fats oils and greases are best treated with water at 60°C or higher temperature.

For heavily contaminated surfaces, manual cleaning is recommended. When removing hydrocarbons, the water should be collected and circulated through an oil separator and sand filter before being discharged to a waste water treatment plant or further filtered and re-used.
